Job summary:

Reporting to the Chief Technical Officer the staff will be responsible to Provides technical guidance in the implementation of HIV programming to increase the adherence and retention among PLHIV and maximize outcomes across the HIV clinical cascade. S/he will support the planning and implementation of Retention, Adherence, and Psychosocial support and Linkage interventions required for optimal HIV care and treatment and PMTCT services.

Duties and Responsibilities

- Provides technical implementation support for the program to implement adherence and retention of PLHIV as per national ART guidelines.
- Provides technical expertise and leadership on best practices and emerging evidence on clientcentered adherence and retention approaches.
- Evaluate adherence support systems and retention approaches, and lead the development of impactful strategies across all population of patients on care.
- Support program sites to establish and oversee ongoing quality improvement initiatives for support with patient retention, adherence, and continuity of treatment.

- Ensure case management model is implemented optimally across all program counties.
- Design and implement strategies to retain priority clients (newly identified clients, TIs, RTC, high VL, AGYW, GBV, PBFW, and CALHIV).
- Supervise and mentor facility adherence officers, peer educators on strategies on continuity of care.
- Provide leadership to make sure that a list of daily appointments, missed opportunities, and clients are followed up on is prepared to guarantee that less than 2% of appointments are missed.
- Verify that all continuity of care tools are fully documented (EMRs, registers, FMATT etc).
- Distributes appropriate job aides, tools and educational material for treatment support employees and counselors.
- Verify that DSD is implemented in every facility and that clients are being monitored in each facility and community.

- Take part in the performance evaluations of the facility adherence officers.
- Strengthen adoption of the Community Strategy implementation for the context of USAID AMPATH Uzima Counties.
